Future of U.S. Leadership Conference of Women Religious

April 2012 Vatican Mandate to LCWR

Citing "serious doctrinal problems which affect many in the consecrated life", the Vatican announced a major reform of LCWR. The Vatican assigned Archbishop J. Peter Sartain of Seattle and two other bishops to provide "review, guidance and approval where necessary in the work of LCWR".

The mandate acknowledged how LCRW faithfully promotes social justice. It also stated:

- · LCRW is silent on the right to life from conception to natural death
- The Church's biblical view of family life and human sexuality is not part of LCWR's agenda in a way that promotes the Church's position on moral and sexual issues
- Public statements by LCWR disagree with or challenge positions taken by the bishops, "who are the Church's authentic teachers of faith and morals"

Another Accusation in Mandate

LCWR's collaboration with the Catholic social justice lobby NETWORK was also criticized. LCWR is grateful to work alongside NETWORK, whose mission of lobbying, organizing and educating for social and economic justice is rooted in the Gospel and Catholic social teaching.

What is LCWR? What is their Response to the Vatican Mandate?

The LCWR numbers 1,500 leaders of U.S. women's congregations, representing 80% of the country's 57,000 women religious. LCWR stated they were "stunned by the conclusions of the Vatican's doctrinal assessment". The LCWR follows canonically approved statutes and noted that "this is a moment of great import for religious life and the wider church".

HomeSafe Georgia provides up to 18 months of mortgage payment help for those unemployed or underemployed while they seek work. After the assistance period, the interest-free loan is forgiven at 20% per year over five years. If you or someone you know are interested in the HomeSafe Georgia program, please take a moment to review the eligibility requirements.

Prequalification checklist:

- □ You are unemployed OR underemployed (25% reduction in income for wage earners; 30% loss in gross receipts for self employed);
- ☐ You own the property and it is your primary residence:
- ☐ You are a legal resident;
- ☐ Your monthly mortgage payment is greater than 25% of your monthly household income;
- ☐ You were current on your mortgage prior to the event where you lost your income;
- ☐ You are no more than six months behind on your mortgage at the time you apply;
- ☐ You do not have more than \$5,000 in liquid assets (does not apply to retirement accounts);
- ☐ You do not have an active bankruptcy:
- ☐ You do not have a tax lien:
- ☐ You have not been convicted of a mortgage related felony in the last ten years;
- ☐ Your property is classified as real estate; and
- ☐ Your total outstanding mortgage balance is not more than \$417,000.

If you are approved for assistance, HomeSafe Georgia will pay a front end reinstatement of up to six months of payments for which you may have been behind.

Participants will pay a partial payment of 5% of their current income toward their mortgage payment. Veterans may request a waiver of the partial payment.

Applications are processed on a first-come, first-served basis. Applications may take up to twelve weeks to process during high volume times. Providing necessary documentation not only allows your application to be worked quickly, it also protects the integrity of the program.
