Every November, the biggest promoter of National Adoption Month is Wendy's hamburger chain. Wendy's founder Dave Thomas, who died in 2002, was adopted as a baby, and he set up his Dave Thomas Foundation to find families for children in need of permanent homes, especially kids in foster care.

On the surface, young Dave's family life was hardly ideal. His adoptive mother died when he was only five years old, and the boy had to move from state to state as his dad searched for work. At age 15, he dropped out of school and moved out on his own to take menial jobs. Still, he was convinced that the love of his "forever family" had prepared him well to face his future with determination, hard work, and faith.

ADOPTION'S CHALLENGES

Not many children today are adopted as young as Dave Thomas was. Only 15% of the 135,000 children adopted in the US each year are babies placed at birth, and a quarter more are little ones from other countries, often from overcrowded institutions. The majority are older children from the child welfare (foster) system. Even so, almost 20,000 children in foster care "age out" of the system every year without being placed in permanent families. What holds prospective families back?

Even for children who join adoptive families early in life, says the American Adoption Congress, adoption is a "life-altering event" that typically entails lasting pain. Their later search for identity "may lead adoptees, particularly in adolescent years, to seek out ways to belong in more extreme fashion than many of their non-adopted peers." Unsurprisingly, then, the BBC reported in September that more than a quarter of adoptive families surveyed in Britain had experienced serious family crises.

ADOPTION'S BLESSINGS

Despite these challenges, though, few British families in the survey expressed regrets about adopting. Instead, their experience had taught them what Dave Thomas knew and what Pope John Paul II said so well: "There is a form of 'procreation' which occurs through acceptance, concern and devotion. The resulting relationship is so intimate and enduring that it is in no way inferior to one based on a biological connection."
