What is a planned gift?



A planned gift is a gift that requires forethought. It comes from assets or from a will or estate. Many donors work with a professional to help them with a planned gift. Some donors make gifts during their lifetime to causes they care about. Many find that making a gift in their will (or a bequest) is the easiest way to support the Catholic community in the future. The goal of planned giving is to help you plan your estate and charitable giving in a way that benefits you, your family, and the causes you care about.

Who can make a planned gift?



Anyone can create a Catholic legacy for causes they care about. The Catholic Foundation works with donors of all levels. You do not have to be wealthy to make a gift in your will. We are also blessed to work with donors who have greater assets, but who still want their legacy professionally managed. Lastly, we help Catholic philanthropists interested in making a substantial planned gifts.

Why consider planned giving?



We understand and respect your desire to give back to the Church and provide a legacy of faith for future generations. You can support the future of the Catholic Church by making your plans now to benefit your parish and the Catholic community.
